ORDINANCE #88-2 SECTION 3

BOWS AND ARROWS MAY BE DISCHARGED WITHIN THE RESTRICTED AREA IF THE PERSON FIRST OBTAINS A PERMIT. RESIDENTS AND/OR LANDOWNERS MAY APPLY FOR AN ARCHERY PERMIT FROM THE TOWN BOARD ALLOWING THE DISCHARGE OF A BOW, PROVIDING THE APPLICANT:

- A. DESIGNATES SUFFICIENT PROPERTY TO SAFELY DISCHARGE A BOW.**
- B. MAKES ALL NECESSARY SAFETY PRECAUTIONS TO PROTECT THE PUBLIC AND PARTICIPANTS.**
- C. ASSUMES FULL RESPONSIBILITY FOR INJURY OR DAMAGE WHICH MIGHT RESULT.**

THE TOWN BOARD SHALL REVIEW EACH PERMIT APPLICATION ON A CASE BY CASE BASIS, AND IT SHALL BE ENTITLED TO PLACE ANY RESTRICTIONS OR DENY ANY PERMITS AS IT DEEMS NECESSARY TO PROVIDE FOR THE PUBLIC SAFETY AND ORDER.

AN ARCHERY PERMIT IS VALID ONLY UPON THE LAND AREA DESCRIBED IN THE PERMIT, AND SHALL BE SUBJECT TO ANY RESTRICTIONS THE TOWN BOARD PRESCRIBES.
