ORDINANCE #88-2 SECTION 2

**WEAPONS MAY BE DISCHARGED WITHIN THE RESTRICTED AREA ON TRACTS OF
LAND WHICH EXCEED 40 CONTIGUOUS ACRES AND ARE OWNED BY THE SAME
LANDOWNER, PROVIDED THE FOLLOWING CONDITIONS ARE FIRST MET:**

- A. A WRITTEN PERMIT IS OBTAINED BY THE LANDOWNER FROM THE SEYMOUR
TOWN BOARD. THE TOWN BOARD SHALL REVIEW EACH PERMIT
APPLICATION ON A CASE BY CASE BASIS, AND IT SHALL BE ENTITLED TO
PLACE ANY RESTRICTIONS OR DENY ANY PERMITS AS IT DEEMS NECESSARY
TO PROVIDE FOR THE PUBLIC SAFETY AND ORDER. THIS PERMIT IS GOOD
ONLY FOR THE PROPERTY DESCRIBED ON THE PERMIT AND SHALL BE
SUBJECT TO ANY RESTRICTIONS THE TOWN BOARD PRESCRIBES.**
- B. ACCESS MUST BE RESTRICTED TO THE LANDOWNER AND THOSE
AUTHORIZED BY THE LANDOWNER. ALL HUNTERS SHALL CARRY ON THEIR
PERSON, WRITTEN PERMISSION FROM THE LANDOWNER.**
- C. THE LANDOWNER SHALL INFORM ALL HUNTERS OF THE LIMITS OF THE
HUNTING AREA.**
- D. ALL STATE STATUTES MUST BE OBEYED.**
