FROM YOUR TOWN CHAIR

Happy Autumn Fellow Residents,

The reconstruction of over two miles of Town road is completed. Thanks for your patience during the construction. We have also replaced some metal culverts that rusted out and were failing, with plastic culverts. These plastic culverts should last longer. Our Town roads average a 7 on a scale of 1 to 10 in terms of quality which puts us in the "good" category. With increased traffic and larger vehicles with increased weight, it is a challenge to keep the roads in good condition. Our crew (Kerry and John) do a commendable job of keeping our roads in good condition. Recently the State passed an Implements of Husbandry Law which allows farm equipment to exceed the current weight restrictions on Town and County roads by 15%. The Town Board plans to draft a resolution to limit that equipment to that standard. If we do not, there would be no limit to the weight restrictions that farm equipment would have to follow. We will still charge for damage to Town roads and we will still post weight limits in the spring to protect our investment in roads. Road maintenance is the largest expense in our annual budget.

The Town purchased some property two years ago which contained some timber. We have decided to harvest some of that timber this year and have contracted with a logger to thin the pines and remove some of the oak. We have not yet decided what to do with the proceeds, but I would recommend spending it on improvements to our recreation program on that property.

We have posted the property to hunting only with permission. The Board decided that we would limit hunting on the property to Town of Seymour residents only. This allows us to control the number of hunters as the adjoining property owners have concerns with hunters going on their property.

Please retrieve your garbage containers promptly after the garbage has been collected and please do not place them in the roadway. Please back them off the road so vehicles do not hit them or have to swerve to avoid them.

Our Clerk/Treasurer, Miranda Hoffman, has been doing an excellent job of keeping up with voting regulation changes this year.

With winter approaching we will have snow, I bet! As a reminder, do not plow or push your snow across the road.

Enjoy the Autumn and Winter Seasons!

ELECTION NEWS FROM YOUR CLERK/TREASURER

As of October 9, 2014 the U.S. Supreme Court ordered that the photo ID requirement will **not** be in effect for the November 4, 2014 General Election. The Government Accountability Board staff and local clerks, including myself, have worked hard to implement the Photo ID requirement since the Seventh Circuit Court of Appeals order of September 12, 2014. In order to minimize confusion and uncertainty regarding photo ID, contact me at (715) 834-4999 if you have any questions!

AS OF THE DATE OF THIS PUBLICATION PHOTO ID IS NOT REQUIRED

If Wisconsin Voter Photo ID is required in the future, I have included a list of acceptable IDs below.

What IDs would be acceptable?

These photo IDs would be acceptable for voting purposes. They could be unexpired or expired after the date of the most recent general election, November 6, 2012.

- A Wisconsin DoT-issued driver license
- A Wisconsin DoT-issued ID card
- An ID card issued by a US uniformed service – military ID
- A U.S. Passport

These photo IDs would also be acceptable for voting, but they must be unexpired.

- A certificate of naturalization that was issued not earlier than two years before November 4, 2014.
- An unexpired driving receipt issued by the Wisconsin DoT
- An unexpired ID receipt issued by the Wisconsin DoT
- An ID card issued by a Wisconsin-accredited university or college that contains date of issuance, signature of student, and an expiration date no later than two years after the date of issuance. Also, the university or college ID must be accompanied by a separate document that proves enrollment

REGISTER TO VOTE

By Mail: Last day for electors to register by mail is Wednesday, October 15, 2014 for the Nov 4th election

Clerk's Office: Last day for electors to register to vote in the Nov. 4th election at the Town of Seymour Clerk's Office is October 31, 2014.

Election Day: Electors can register to vote on Election Day at the Seymour Town Hall. If you register on Election Day, you will need to provide proof of residence at the registration table. If you have questions about what types of documents will work for proof of residence, please contact me at (715) 834-4999 or e-mail seymour.town@att.net.

ABSENTEE VOTING

If you are unable or unwilling to go to your polling location on Election Day, you may request an absentee ballot in person or via mail.

In-person Absentee Voting:

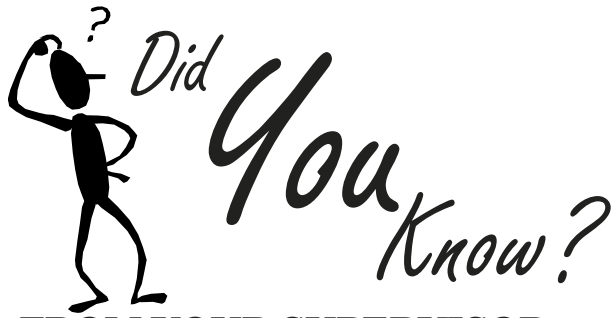

The office will be open additional hours on Friday, October 31, 2014 and will have in-person absentee voting from 9:00 AM to 5:00 PM.

If you want an **absentee ballot mailed** to you, Thursday, October 30, 2014 is the last day for you to request an absentee ballot by mail for the Nov. 4th election (except military and indefinitely confined voters).

To request an absentee ballot via mail, please fill out form GAB-121 Absentee Ballot Request Form. This form can be found on the Town website under "Forms and Permits" (www.townofseymour.org).

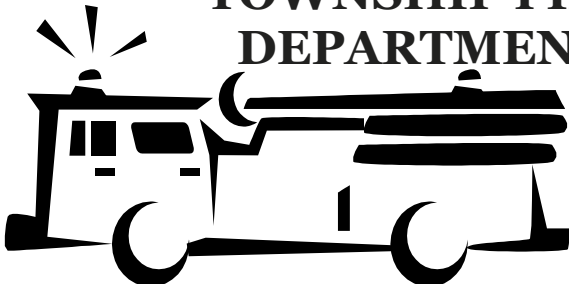

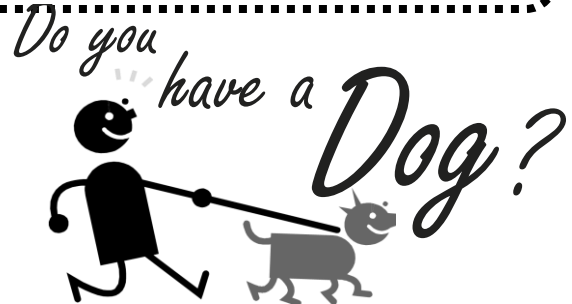

DOG LICENSES ARE GOOD FOR THE CALENDAR YEAR!

Dogs more than 5 months of age need to be licensed. Licenses may be obtained in-person during office hours or via mail. Please include a self-addressed stamped envelope if you mail your dog license, so that we can send your license back to you.

FEES: \$7.00 for neutered/spayed dogs
\$18.00 for unaltered dogs

Late fee of \$5.00 per dog is charged beginning April 1st, 2015. If a dog is not licensed by June 1st, 2015, an additional \$50 late fee is charged. Violation Citations will be issued to habitual offenders.

Please be sure to bring your current CERTIFICATE OF RABIES VACCINATION when applying for a license, in person or by mail. A license cannot be issued without proof that the dog is current on rabies vaccine.

Dog tags for 2015 will be available December 2014. Be sure to get to the Town Hall or mail your information before April 1, 2015 to avoid late fees and to avoid extra mailing expenses to the Town.

LANDFILL EXPANSION

Earlier this spring, the Town Board received notification from Advanced Disposal Services Seven Mile Creek Landfill, LLC that it is their intent to expand the current landfill vertically approximately 20 feet over a portion of the existing footprint.

The facility takes in about 375,000 tons of garbage each year from south of Black River Falls, WI over to St. Paul, MN.



FROM THE SEYMOUR BALL CLUB

It was another great year for Seymour Ball Club. Boys and girls ages 4-18, totaling over 400 kids, played on 38 teams. Tournaments held by the boys and girls brought in over 70 teams from all over Wisconsin and Minnesota.

Improvements to the park this year included a new irrigation pump, fence replacement, and a new John Deere tractor all funded by the ball club. Next year we will be looking into new batting cages and possibly scoreboards if we can find the funding.

We would like to thank all the residents of Seymour for being patient with our parking along the road during our busy days.

Without the expansion, the landfill would have about five years of life remaining. The proposed expansion would add approximately three years to the life of the landfill.

A negotiating committee has been established which includes representatives from the City of Eau Claire, Eau Claire County and the Town of Seymour to negotiate the proposed expansion. Doug Kranig has been appointed as the Town of Seymour representative for this committee.

A public hearing to be held at the Seymour Town Hall is tentatively scheduled for the first week in December. An explanation of the proposed expansion will be presented and a question and answer time will be allowed.

BUILDING INSPECTOR**

Planning to build or remodel on your property? Remember, you need a building permit for most projects, including roofing and residing.

If you are not sure if you need a permit or if you have any questions, please call the building inspector, Fred Hankel, at (715)577-7983.

Most jobs require a licensed or registered contractor. Make sure you have that information when applying for a building permit.

Changes are being made to the WI Safety and Building Division, Electrical Code s. 101.862(4) No Person as of April 1, 2013 may install, repair or maintain electric wiring unless the person holds a license or registration issued by the department; unless you reside in the house.

HALL RENTAL

The Town Hall is available to rent. The rates are \$300 rent plus \$150 deposit for Seymour residents. Non-resident fee is \$400 rent plus \$150 deposit. Town of Seymour residents may not rent the hall for non-resident’s use in order to get the reduced rate.

The deposit will be returned within approximately two weeks if the hall is cleaned according to the contract and there are no damages.

The park pavilion is also available. The rates are \$25 rent and \$25 deposit without electricity. For rentals with electricity, the rent is \$40 and the deposit is \$40.
